- I. Earlier, the SEIAA, AP had issued Environmental Clearance for the **proposed 30 MW Captive Power Plant** in favour of **M/s. Durga Cement Works (a unit of M/s. Andhra Cements Ltd.), Durgapuram (V), Dachepalli (M), Guntur District** vide reference 1st cited, mentioning the funds earmarked for Corporate Social Responsibility (CSR) activities (Capital cost of Rs 54.0 crores & Recurring cost of Rs. 10.8 crores /annum).
- II. The proponent vide reference 2nd cited informed that there is a typographical error in the EC order w.r.t. funds earmarked for CSR activities was mentioned as crores instead of lakhs and requested to issue amendment to the EC order.
- III. The request of the proponent was examined by the State Level Expert Appraisal Committee (SEAC) in its meeting held on 27.08.2013. Based on the information furnished; the Committee considered the request of the proponent and recommended to issue amendment to the EC order. The State Level Environment Impact Assessment Authority (SEIAA), in its meeting held on 09.10.2013 examined the request of the proponent and the recommendations of SEAC, and decided to issue amendment to the Environmental Clearance. Hence, the following amendment is made to the EC order issued vide reference 1st cited:

(b) The condition no. xi. mentioned under B. General conditions shall be read as:

“The funds earmarked for environmental protection measures (Capital cost of Rs 16.3 crores & Recurring cost of Rs. 5.1 crores /annum) and Corporate Social Responsibility (CSR) activities (Capital cost of Rs. 54.0 lakhs & Recurring cost of Rs. 10.8 lakhs /annum) should be kept in separate account and should not be diverted for other purpose. Year wise expenditure should be reported to the Ministry and its Regional Office located at Bangalore”
